Hon'ble Minister, Revenue & Disaster Management, Sri Jogen Mohan would like to state:

As per the reports received from the 23 District Commissioners of the State :

(a) 4766 families have been evicted in Assam from Government land during 2016-2021. Details

of each and every eviction drive with place of eviction and date are enclosed at annexure "A" (Via Online)

(b) 5854 families have been evicted in Assam from Government land from May 20, 2022 to till now under this Government. Details of each and every eviction drive with place of eviction and date are enclosed at annexure "A" (Via Online)

(c) 630 families have been given rehabilitation by the Government since 2021. Details are enclosed at annexure "A" (Via Online)

(d) 4 People have died during the eviction since 2016. Details of deceased are enclosed at annexure "A" (Via Online)

(e) Those evicted people, who have applied and also qualifying for the land titles under the Mission Basundhara Scheme have been given land titles.

(f) 1,83,524 people don't have any land titles in Assam. Details of deceased are enclosed at annexure "A" (Via Online)

(g) In the last 10 years, 17,390 people lost homes in the floods and erosion. 1563 of them are given land and rehabilitation. Moreover, Rehabilitation Grant (RG) as per SDRF norms has also been provided to few affected people. Details of the flood and erosion affected people are enclosed at annexure "A" (Via Online).

a. During the year 2016-2021, 81 Nos. of people of 12 Nos. families have been evicted on 11-08-2020 under Kalgachia Revenue Circle.

During the year 2016-2021, 207 Nos. people of 41 Nos. families have been evicted from the village of Katajhar Pathar on 14-12-2020 and 103 Nos. of people of 17 Nos. families have been evicted from the village Satbhanir tup on 16-02-2020 under Barnagar Revenue Circle.

- b. During the year of 2022-2024, 265 Nos. people of 72 Nos. families have been evicted from the village of Khudnabari on 03-12-2022 and 88 Nos. peoples of 22 families have been evicted from the village Domoni on 03/12/2022 and 70 Nos. peoples of 17 families have been evicted from the Barpeta Road Town on 12-03-2022 under Barnagar Revenue Circle and 45 Nos. families have been evicted from Govt. land at Satrakanara NC 12 No. seat on 26-12-2022 under Baghbar Revenue Circle.
- c. No families have been rehabilited by the Govt. since 2021. All 45 Nos. of evicted families have been shifted to their own patta land under Baghbar Revenue Circle.
- d. No peoples have been died during the eviction since 2016 under Barpeta District.

- g. 2952 families lost their home due to erosion and flood during last 10 years under Barpeta District. Financial assistance were provided to each affected family. Those who have applied through Mission Basundhara 2.0 were considered.

- b. Under Darrang district, from May 20, 2022 to till now 253 nos. of people of Duliapara Grant village and N.C. Nanglichar Orang National Forest of Dalgaon Revenue Circle have been evicted.
- c. 1891 nos. of families who have been have been evicted under Sipajhar Revenue Circle have been shifted to Dalgaon and Pub-Mangaldai Revenue Circle. 
